HE recording of the monuments in this series is made possible by a major grant from the Arts and Humanities Research Council which provides for the salaries of the two Research Fellows as well as travel and other incidental expenses for the authors of the volumes. The project is based at Durham University, and the Department of Archaeology has housed and continued to supply invaluable support for the home team. I am grateful also for a Visiting Fellowship to All Souls College, Oxford which enabled me to begin the library research for this volume. The British Academy has generously funded the publication, as it has done from the beginning of the series. In 2004, the Academy also provided a grant for the purchase of a high-grade digital camera which has resulted in a transformation of the field record, as noted below. The publication costs of this volume have also been assisted by a helpful grant from the St Andrew's Conservation Trust, which is concerned with projects in Somerset and the surrounding areas.

With this volume my interest in Anglo-Saxon stone sculpture comes full circle, in that when I first became involved in this research I resolved to see all known sculptures before writing my first book on the subject. I began therefore in the south-west and worked my way east and north, photographing (aided by a car battery and headlights mounted on a push chair) over many subsequent summers. Twenty years later, the project had been established, and the first CASSS volume was published (Cramp 1984). My notebooks for 1964 are woefully sketchy compared with the recording forms of today, but have proved surprisingly useful for a few items in this volume, particularly for those sculptures which have been subsequently lost or stolen. I am deeply indebted to those who accompanied me on the originally very leisurely journeys through western Wessex, such as the late Joan Gummer, the late Barbara Robertson and Ann Morley, and to those who assisted in the more pressurised visits over the last three years, particularly as a good companion, John Crook, who is responsible for many of the photographs in this volume. Finally the whistle-stop journeys of Derek Craig and Ken. Jukes to complete the record, and in many cases to improve my earlier images with excellent digital photographs, were truly herculean. Their patience, professionalism, and good humour in often trying circumstances were outstanding.

Many people have assisted by providing me with information and helping to gain access to the material. I would like to thank all the museum curators who have provided access to their collections, not once but several times, since epigrapher, geologist and archaeologist did not usually travel together and I have returned on several occasions asking for another visit. I would particularly thank Mrs Vicky Dawson of Glastonbury Abbey Museum, Ms Linda Jones of the Bath Abbey Heritage Vaults, Dr Stephen Minnitt of the Somerset County Museum at Taunton; Mr T.
